The information given by you in your application may be used in the Programme should you be selected.
2. You acknowledge and agree to abide by the rules, regulations, terms and conditions for the Programme as determined by the Producer (the "Rules") and you acknowledge that the Rules may be changed (including without limitation verbally) at any time by the Producer at their sole discretion and that you will be bound by such Rules. The Producers' decisions shall be final.

4. The Producer cannot guarantee that you will be contacted for an audition or to take part in the Programme, or that your participation will be exploited in any media at any time. The decision of the Producer is final.
5. Applicants may be invited to attend an audition at a time and place to be notified by the Producer. The Producer cannot guarantee that you will be offered an audition or that you will be offered an audition in your preferred city.
6. The closing date and time for submitting your application is as stated in the relevant promotion and/or on the website at www.itv.com. The Producer may change the closing date and time at any time in their sole discretion, without notice for reasons beyond the Producer's reasonable control.
7. Following the auditions successful applicants may be selected to take part in the Programme at the sole discretion of the Producers whose decision will be final.
